#### **Petitions and Communications continued**

Jonathan Seyferth, Assistant City Manager presented the Council with some significant facts on the economic impact that Continental Dairy and fairlife has had, and continues to have on Coopersville's community. Mr Seyferth stated that the situation is similar to the mythical Toyota Plant.

Mr. Seyferth informed the Council that Continental Dairy and fairlife paid approximately 3.4 million in taxes for 2015, stating further that Delphi wasn't paying, in 2008, what Continental Dairy and fairlife are paying now.

Mr. Seyferth stated that it is important that we foster the businesses that are currently located in our City.

Mayor Lloyd spoke on the importance of Continental Dairy and fairlifes existence in the City.

Steven Patrick, City Manager stated that there is talk that Continental Dairy and fairlife are driving the upcoming water and sewer projects. Mr. Patrick stated further that the upgrades have been needed for sometime whether Continental Dairy and fairlife were here or not, and that enterprise funds are used to upgrade infrastructure.

Mayor Lloyd requested an update from the Utilities Committee from their first meeting.

Council member Meintsma stated that it is very enlightening how challenging the water and sewer projects are, and stated further that closure is needed from Allendale, Muskegon, and on the sewer from Grand Rapids. Council member Meintsma stated that they have placed the issues back in the hands of the City Manager as they are working within very tight time frames.

Council member Lampe stated that the water and sewer projects are very interesting dynamics while Council member Mooney stated that serving on the Utilities Committee is real great and real fun.

Council member Meintsma stated further that it is going to be on all Council members to make some big decisions.
