Scheduled Guests & Public Hearings

Gary Rosema, Sheriff of the Ottawa County Sheriff's Department was present, as were several of the Ottawa County Deputies, to celebrate the 20th Anniversary of the relationship between the Ottawa County Sheriff's Office and the City of Coopersville.

Sheriff Rosema presented Council with some of his personal background history and a power point showing the history of the relationship between the Ottawa County Sheriff's Department and the City of Coopersville from the origination date to the present.

Mayor Lloyd presented Sheriff Rosema with a Mayoral Proclamation for the Ottawa County Sheriff's Department, further thanking him and the entire department for their excellent service to the City of Coopersville.

Tom Muller, City Resident expressed his concerns to Council on the following issues:

- Six (6) street lights that have been on constantly for three (3) years which is wasting taxpayer's money. The lights are located on Cleveland, East, Randall and Spring Streets
- All areas of Coopersville are not on the Coopersville Chamber of Commerce map.
- There are no sidewalks or paths leading to town for the children whom reside in the Eagle Ridge Development which raises a safety concern with him for their well being.

- Mr. Muller stated that the City has recently spent money for concrete on Randall in front of the Dairy Plant and that he hopes that the City could spend some money on some type of paths or sidewalks and possibly some type of education system on the safety of walking in traffic for the children whom reside in the Eagle Ridge Development.
