Mr. Patrick informed the Council that he would be making two (2) proposals to Continental Dairy later this week on the upgrades to the WWTP that would include the 2.9 million dollars in grant money that Continental has received from the MEDC. Mr. Patrick stated further that the Engineers have informed him that the 2.1 million dollars from the city's funds and the 2.9 million dollars from Continental Dairy will still not be enough funds to complete the upgrade that will be needed.

Mr. Patrick has requested for the engineering firms to inform him of what upgrades could be obtained with five (5) million dollars and to also provide him with a cost for what we actually need to do according to their findings.
