Motion by Council Member Wheeler with second by Council Member Mooney to approve the proposed Ordinance Amendment, Section 648.02 – Noise Control with the removal of Items C & E. Motion carried with Council Member Lampe opposing. (2019-066)

Matt McKinnon, Recreation Director presented a request to Council to increase the sports fee due to the significant increases in attendance in recreation programs. Cost for programmatic materials such as field paint, t-shirts, and umpire costs have risen. Mr. McKinnon proposed an increase in fees to the following sports which utilize more resources than other sports:

- *Baseball, Football Soccer, Softball - \$10.00 increase*
- *Basketball, Volleyball - \$5.00 increase*
- *Cheer, No change from current fee*

Increase in fees will change Family Maximum, (3 or more participants in a family) from current \$130.00 (resident) To \$150.00.

Increase in fees will change Family Maximum, (3 or more participants in a family) from current \$175.00 (non-resident) to \$200.00.

Motion by Council Member Wheeler with second by Council Member Mooney to approve the Resolution to Update Fees to the Fee Schedule for the Noise Ordinance Variance Application fee of \$125.00 and the increases to the Recreational Program fees as follows: Motion carried unanimously. (2019-067)

- *Basketball, Volleyball - \$5.00 increase*
- *Cheer, No change from current fee*
- *Increase in fees will change Family Maximum, (3 or more participants in a family) from current \$130.00 (resident)*
- *To \$150.00.*
- *Increase in fees will change Family Maximum, (3 or more participants in a family) from current \$175.00 (non-resident) to \$200.00.*

Motion by Council Member Lampe with second by Council Member Bush to approve the Easement from the City to Coopersville Area Public Schools to place their new school sign on the southside of Campus Drive near 48th Avenue. The school will be taking over the cost for the streetlight at 48th Avenue and Campus Drive. Motion carried unanimously. (2019-068)

Motion by Council Member Wheeler with second by Council Member Bush to approve the Licensing Agreement with Consumers Energy to maintain the City's use of the East DPW Driveway exiting on to Main Street. The City will incur a \$75.00 annual fee payable to Consumers Energy. In year one the fee will be \$100.00 as there is also a one-time \$25.00 administrative fee. Motion carried unanimously. (2019-069)

Motion by Council Member Wheeler with second by Council Member Mooney to approve the Charitable Gaming Resolution for the Coopersville Historical Society. Motion carried unanimously. (2019-070)

Motion by Council Member Lampe with second by Council Member Bush to approve the Notice of Intent to Issue Capital Improvement Bonds for the 2nd River Crossing not to exceed \$3.0 million dollars. Motion carried unanimously. (2019-071)

Motion by Council Member Wheeler with second by Council Member Bush to approve the securing of Baker Tilly's Services for securing the funds for the 2nd River Crossing. Motion carried unanimously. (2019-072)

Motion by Council Member Wheeler with second by Council Member Mooney to approve the purchase of a new Grasshopper Mower with a 61" deck for the WWTP from George Hofacker Equipment totaling \$12,527.90. Motion carried unanimously. (2019-073)

City Manager's Report

City Manager, Jonathan Seyferth reported on the recent Traffic Study from 48th Avenue to North of Cleveland, which included Campus Drive, Randall Street and Ironwood. The study showed that the current amounts of traffic do not trigger any mitigation. Only if all these areas were built out would improvements need to be made.

The study rated the City at a Level "C" and the Study stated that the current results were not created by just one development. Should Eagle Ridge build out to their maximum capacity, improvements will have to be made.

Ottawa County Road Commission and the City should work on improvements to the areas of the Traffic Study over the next ten (10) to twelve (12) years.
