During his recent remodel the plumbing was re-done but he was informed he still needed a grinder pump, but he is on top of hill and wonders why? Also, the assessor raised the value of his home for widening the doorways to allow for wheelchair access to various rooms. Carl Snider – 228 E Randall stated that he along with 2 other neighbors attended meetings in February, March & April of 1988 to connect to the city sewer. The city agreed that the homeowners would pay for grinder pumps and installation and the city would maintain the system going forward.

Jim Vandermullen – 236 E Randall is not sure of the year but thinks it was the mid 1990's the septic system was not adequate, so he paid Van's Contracting to install the grinder pump system and the city took it over. Only one time has service been needed.
