Discussion/Action

1) Reserve of Coopersville Site Condominium Phase 2 and PUD Site Plan

Planning Director Alek Mizikar stated that they will install an entryway sign at the entrance of 48th Avenue and Peach.

Discussion/Action continued

1) Reserve of Coopersville Site Condominium Phase 2 and PUD Site Plan

Motion by Commissioner Brown with second by Commissioner Degeus to approve the Reserve of Coopersville Site Condominium Phase 2 and the PUD Site Plan with the following staff recommendations: Motion carried unanimously.

- Any future changes to PUD site plan phasing shall be administratively reviewed as a "minor change" to the Final PUD Site Plan. City Staff may bring future changes to the phasing timeline if it is deemed a substantial change.
- Review and approval of Phase 2 construction plans by city engineer.
- Sign permit to be obtained with city staff prior to construction of sign.
- Construction equipment to use separate access point for ingress/egress.

2)Appointment of Planning Commission Member to the Zoning Board of Appeals

Motion by Commissioner Degeus with second by Commissioner Brown to approve the appointment of Sarah Petersen to the Zoning board of Appeals as the Planning Commission Representative. Motion carried unanimously.
