Motion by Council member Vander Kolk with second by Council member Sprague to approve the minutes of the regular City Council meeting of January 14, 2008. Carried unanimously. (2008-021)

Motion by Council member Sprague with second by Council member Vander Kolk to approve payment on the invoice from Law Weathers & Richardson for general municipal services totaling \$1,352.46. Carried unanimously. (2008-022)

Motion by Council member Whitman with second by Council member Sprague to approve payment on the invoice from Michigan Economic Developers Association for 2008 annual membership dues totaling \$235.00. Carried unanimously. (2008-023)

Motion by Council member Sprague with second by Council member Vander Kolk to approve payment on the invoice from Ottawa County for December Communities that Care totaling \$3,685.58. Carried unanimously. (2008-024)
