REGULAR MEETING OF THE CITY COUNCIL

SEPTEMBER 22, 2008

Mayor Kenneth L. Bush called the meeting to order at 7:00 P.M.

Motion by Council member Whitman with second by Council member Vander Kolk to excuse the absence of Council member Scherff. Carried unanimously. (2008-205)

Motion by Council member Vander Kolk with second by Council member Whitman to approve the minutes of the regular City Council meeting of September 8, 2008. Carried unanimously. (2008-206)

Motion by Council member Sprague to approve the checks written for the period ending September 22, 2008 totaling \$178,082.55, with the exception of check #40450 in the amount of \$53,775.16 payable to Pavement Restoration. Motion failed for lack of support.

Motion by Council member Vander Kolk with second by Council member Whitman to approve the checks written for the period ending September 22, 2008 totaling \$178,082.55. Motion carries with Sprague voting no. (2008-207)

Motion by Council member Sprague with second by Council member Vander Kolk to approve Ordinance No. 415 to adopt by reference the 2006 Michigan Building Code, Michigan Rehabilitation of Existing Building Code, Michigan Mechanical Code, Michigan Plumbing Code, and Michigan Residential Code; 2005 National Electrical Code; and repeal 2003 Michigan Uniform Energy Code. Carried unanimously. (2008-208)

Motion by Council member Whitman with second by Council member Vander Kolk to approve Ordinance No. 416 which amends 1276.04 by increasing the allowable height of structures in I-1 zoned property. Carried unanimously. (2008-209)

Motion by Council member Vander Kolk with second by Council member Sprague to receive and file the Council information packet, which contains: Grand Rapids Press 9/11/08 article, "DDA questions plans for pocket park;" Time Magazine 9/15/08 article, "You Want a Revolution. More cities are using roundabouts to help save drivers time (and gas money);" Detroit Free Press 9/17/08 article, "More metro Detroiters are enrolling at GVSU;" Draft Downtown Development Authority board meeting minutes of 9/9/08; Northeast Ottawa District Library meeting minutes of 8/20/08; and City of Coopersville 2008-2009 Budget. Carried unanimously. (2008-210)
