Motion by Council member Whitman with second by Council member Allen to approve the minutes of the regular City Council meeting of September 13, 2010. Carried unanimously. (2010-203)

Motion by Council member Lloyd with second by Council member Vander Kolk to approve payment on invoice from Nantz, Litowich for general labor and employment services totaling \$102.50. Carried unanimously. (2010-205)

Motion by Council member Lloyd with second by Council member Vander Kolk to approve payment on invoice from OMM Engineering for WWTP upgrade totaling \$2,817.58. Carried unanimously. (2010-206)

Motion by Council member Vander Kolk with second by Council member Allen to approve checks written for period ending September 27, 2010 totaling \$116,536.67. Carried unanimously. (2010-207)

Motion by Council member Whitman with second by Council member Meinstma to adopt an ordinance to impose medical marijuana moratorium. Carried unanimously. (2010-208)

Motion by Council member Crandle with second by Council member Allen to pursue obtaining bids for sidewalks to be installed on 64th Street between Main and Randall. Carried unanimously. (2010-209)

Motion by Council member Lloyd with second by Council member Meinstma to appoint John Scherff to the Zoning Board of Appeals as an Alternate member upon recommendation by Mayor Bush. Motion carried with Council member Allen dissenting. (2010-210)

Mayor Bush recommended to appoint Bradley Sprague Sr. as a regular member to the Zoning Board of Appeals. No action was taken by the Council.

Motion by Council member Meinstma with second by Council member Lloyd to receive and file the council information packet which consists of: Coopersville/Polkton Fire Authority 9/14/10 minutes; Emergency Services minutes of 7/19/10 and 9/20/10. Carried unanimously. (2010-211)
