MARCH 14, 2011

Mayor Ken Bush called the meeting to order at 7:00 P.M.

Motion by Council member Vander Kolk with second by Council member Lloyd to approve the minutes of the City Council meeting of February 28, 2011. Carried unanimously. (2011-044)

Mayor Bush opened the floor for citizens' comments or suggestions. There were none.

Motion by Council member Whitman with second by Council member Vander Kolk to approve payment on invoices from Law Weathers for contract review-sewer project 2009/2010 and ordinance enforcement totaling \$1,440.00. Carried unanimously. (2011-045)

Motion by Council member Lloyd with second by Council member Meintsma to approve payment on invoice from Ottawa County for January policing services totaling \$41,255.33. Carried unanimously. (2011-046)

Motion by Council member Whitman with second by Council member Lloyd to approve payment on invoice from Ottawa County for Final FY 2010 policing services totaling \$1,625.94. Carried unanimously. (2011-047)

Motion by Council member Lloyd with second by Council member Vander Kolk to approve payment on invoice from Ottawa County for Haz-Mat Response/Technical Rescue—Final 2010 totaling \$159.81. Carried unanimously. (2011-048)

Motion by Council member Lloyd with second by Council member Vander Kolk to approve checks written for period ending March 14, 2011 totaling \$416,198.83. Carried unanimously. (2011-049)

Motion by Council member Lloyd with second by Council member Vander Kolk to adopt Ordinance 435 to adopt by reference the Uniform Traffic Code for Cities, Townships and Villages. Motion carries 5-1 with Council member Crandle dissenting. (2011-050)

Motion by Council member Lloyd with second by Council member Vander Kolk to adopt Ordinance 436 to adopt by reference the Michigan Motor Vehicle Code. Motion carried 5–1 with Council member Crandle dissenting. (2011–051)

Motion by Council member Whitman with second by Council member Meintsma to approve resolution to extend the medical marihuana moratorium of Ordinance 430 an additional six months. Carried unanimously. (2011–052)

Motion by Council member Crandle with second by Council member Lloyd to approve a resolution to amend the Fees & Charges. Carried unanimously. (2011–053)

Motion by Council member Vander Kolk with second by Council member Lloyd to receive and file council information which contains: March 10, 2011 memo to city council regarding DDA Board & Liquor License, Coopersville resolution 2000-68, and (11/13/07) Economic Development Fast Facts; and February permits issued. Carried unanimously. (2011–054)

Motion by Council member Whitman with second by Council member Meintsma to excuse the absence of Council member Allen. Carried unanimously. (2011–055)

City Manager Patrick invited council members to attend the “Get Motivated!” seminar with city staff members on April 14, 2011 and indicated that he intended to close city hall on that day so that staff could take advantage of this rare opportunity.
