#### **Consent Agenda**

Motion by Council Member Bush with second by Council Member Lampe to approve the Consent Agenda as presented. Motion carried unanimously. (2022 – 123)

### **Petitions and Communications**

Joshua Morgan, Ottawa County Deputy Equalization Director, and Carla Hill, Ottawa County Assessing Division Manager were present and explained the changes to Public Act 253 that were made in December 2020 on the handling of poverty exemptions by governmental units, and the reason for the request for Council to approve the updated poverty exemption guidelines and application.

Motion by Council Member Degeus with second by Council Member Weise to approve the Resolution for the Poverty Exemption Policy. Motion carried unanimously. (2022 – 124)

Motion by Council Member Bush with second by Council Member Gavin to approve the appointment of Tammy Huff as an Alternate Board of Review Member. Motion carried unanimously. (2022 – 125)

Motion by Council Member Weise with second by Council Member Gerard to approve the proposed 2023 water and Sewer Rate Increase. The water rate will increase from the current rate of \$3.366 per 100 cubic feet of usage to \$3.471 per 100 cubic feet of usage. The sewer rate will increase from the current rate of \$2.805 per 100 cubic feet of usage to \$2.879 per 100 cubic feet of usage. Discussion was held on the possibility of increasing the rate further for the larger commercial users. Council Members requested that further research be completed and presented to them in January, on what the County of Muskegon and other municipalities are charging their commercial users per 100 cubic feet of usage. Motion carried unanimously. (2022 – 126)

Discussion took place on the proposed amendments to Chapter 678, Weeds and Grass ordinance. Council Members recommended to hold a public hearing on the proposed ordinance amendment at the January 2023 Council meeting. Motion by Council Member Gavin with second by Council Member Weise to approve the Water Bond Payoff totaling \$1,136,280.25. Motion carried unanimously. (2022 – 127)

Motion by Council Member Gavin with second by Council Member Lampe to approve the proposed contract with USA Mobile Drug Testing. Motion carried unanimously. (2022 – 128)

Motion by Council Member Bush with second by Council Member Gavin to approve the appointment of Charlie Vander Kolk to the Local Officers Compensation Commission to fulfill an open five (5) year term. Mr. Vander Kolk will replace Michael Karbon. Motion carried unanimously. (2022 – 129)
